The UK market for underground pipes will demonstrate strong annual growth over the next few years, reflecting the combined effects of utilities' expenditure plans and the improving economy increasing construction-related demand. However, demand is likely to decline in 2015 before returning to growth in 2016 due to the expenditure plans of key sectors.
