Commercial Mortgages - UK

Construction - UK

"Just when the construction market was demonstrating strong growth following the economic disruption of the recession, the UK decided to negotiate an exit from the EU. This has created an unusual level of economic uncertainty, and construction prospects have consequently become even more sector-specific than normal."

Residential Windows & Doors -UK

"The wide range of factors affecting demand for windows and doors in the residential sector tend to lead to strong growth when the economy is performing well, and more challenging times when the economy declines or stagnates. The market therefore tends to exaggerate economic fluctuations, and there will be strong ...

Courier and Express Delivery - UK

"The UK courier and express delivery services market is highly competitive, with heavy pressure on pricing and offerings. Competitiveness is highest in the B2C sector, which has seen demand surge in recent years in line with the growth of online channels."

Security Equipment, Access Control and CCTV - UK

"The UK security equipment market is highly competitive, with large sectors effectively commoditised. This has given rise to competitive pricing structures, and encouraged groups to distinguish themselves from competitors by offering new and innovative security solutions."

Legal Services - UK

"While the current market outlook carries a higher degree of uncertainty following the Brexit vote, the UK legal services market will remain intensely competitive and face continued price pressures. "The uptake of occupational health services in the workplace will be largely driven by how certain economic factors progress over the coming years. Organisations will benefit from proactively developing policy, training and support programmes that recognise the needs of employees with longterm conditions."

"In 2015/16, the first year of the new five-year asset management period AMP6, gross capital expenditure across the water and sewerage industry was recorded at £4.45 billion. Commercial Banking and Finance - UK

"The UK's decision to leave the European Union in June 2016 has created an environment of uncertainty for small business owners, which is likely to continue for the foreseeable future while exit negotiations take place. Railway Engineering - UK

"The largest rail infrastructure project over the next two decades is set to be the development of the national high

Fleet Services - UK

"The fleet services market continues to grow at an impressive rate, driven by an increasingly attractive economic landscape bolstering demand across business channels, while the market is also increasingly being shaped by environmental pressures and technological progress."

Recycling - UK

"The UK recycling industry looks set to undergo an uncertain number of years due to recent stagnation in household recycling rates - the first decline since the millennium - compounded by the recent Brexit vote and ongoing climate of austerity."

Gas Supply and Distribution - UK

"Ofgem has introduced a new regulatory framework, known as the RIIO model, for the current eight-year price controls for gas transmission and distribution networks, which run from April 2013 to March 2021. Under the new framework, the revenue earned by network operators is strongly linked to incentives, innovation and outputs ...

Software - UK

"By far the most significant disruption to the growth of the software market has arisen from the migration of







speed rail network HS2. The hybrid bill, effectively the planning permission for the first phase of HS2, received Royal Assent in February 2017. Major enabling works contracts for the project ...

Children's Social Care - UK

"The fragmented allocation of funding for parental and family support services, the majority of which comes via targeted, time-limited central government grants and not core LA budgets, makes strategic planning difficult and raises doubts over the long-term sustainability of running such services. This provides further difficulties for both commissioners and ...

Estate Agents - UK

"The UK estate agents market is highly fragmented, shaped by a wealth of regional and national operators. The marketplace is also highly fluid and dynamic, subject to significant changes in line with factors such as the rise of online, consumer behaviour and the national economy."

"There was belief prior to the recession that the increased frequency of store refurbishments in what remains an intensely competitive retail sector had broken the highly cyclical nature of the shopfitting sector. "The rapid introduction of new technologies, such as telematics, and the growing importance of data and analytics, have demonstrated to insurance companies just how quickly the market can be disrupted by new ideas or non-traditional competitors. As insurers seek to build partnerships and alliances in the 'insurtech' sector, they must ...

Computer Security - UK

"Computer security continues to be of paramount importance. National defence is increasingly moving to the potential issue of cyber attacks, while commercial companies face the twin challenges of more connected devices (both owned and customers connecting to their systems) and the greater sophistication of cyber crime. Against such a background ...

Contract Catering - UK

"Austerity measures have meant continued strong pressure on public sector bodies to cut spending. While this has led to some outsourcing in the contract catering sector, it has also led to intense price competition and even reductions in some existing contracts. This is particularly true in sectors that have felt ...

Civil Engineering - UK

"The major projects set to drive civil engineering construction output over the next five years include Crossrail, Hinkley Point C, Thames Tideway Tunnel, major road schemes, Network Rail's modernisation programme, and, once fully approved, HS2. However, shortages in skilled labour and construction materials capacity will pose challenges to the industry ...
